Regular Session February 27, 2003

The England Economic and Industrial Development District met in Regular Session at the England Authority Board Room, 1611 Arnold Drive, England Industrial Airpark and Community, Alexandria, Louisiana, on Thursday, February 27, 2003.

There were present: Mr. Martin W. Johnson, Chairman; Mr. Wayne Miller, Vice Chairman, Mr. Richard Bushnell, Mr. Elwood Carroll, Mr. Mike Tudor, Mr. Charles Waites, and Mr. Kit Provine.

Absent: Mr. Wayne Denley

Also present were: Members of the England Authority staff, legal counsel, and members of the public, press and media.

Chairman Martin Johnson, offered the invocation. Mr. Tudor, led the Pledge of Allegiance.

The England Economic and Industrial Development District was duly convened as the governing authority of said District by Mr. Martin Johnson, Chairman, who then stated that the England Economic And Industrial Development District was ready for the transaction of business.

The Chair called on Major Schindler of the 259th ATC. Major Schindler presented to the board the proposed expansion of the warehouse as leased to the ANG. Major Schindler stated the estimated cost of the project is \$800,000.00. Major Schindler also assured the board that ATC services will be maintained regardless of units deployment overseas.

The board expressed its appreciation to Major Schindler, the 259th and the Louisiana National Guard.

Mr. Grafton congratulated the E.A. Airfield crew in having a perfect inspection for the fifth year in a row. He also announced that Delta/ASA will have non-stop regional jet service between AEX and Atlanta, Georgia. There will be two flights a day, non-stop jet service, beginning on May 4, 2003. He will be working to get service on to Dallas.

Fire Chief Roland Cimini stated that the fire department was awarded a grant for Fire Fighter's Safety.
